Dear Scholarship Applicant:

Following is the application for a 2018 CAHP Credit Union Educational Scholarship. Your completed scholarship application and supporting documents must be submitted by **June 29, 2018**. The Scholarship Committee will not consider applications sent after that date. Incomplete or late applications will not be returned to the sender. Please see the bottom of this page for details on how to submit your completed application.

Applicants must meet the following eligibility requirements:

- Applicant must be a CAHP Credit Union primary member at the time of application.
- Applicant must be a U.S. citizen.
- Applicant must be accepted to, or enrolled in, an accredited four-year college or university.
- Applicant must have at least a 3.0 grade point average for all college credits earned (an entering freshmen must have a high school grade point average of at least 3.0).
- Applicant must have no felony convictions.

If you meet eligibility requirements, please complete the following application and attach the following:

- A personal statement outlining your academic goals and objectives.
Include your reasons for attending college and other information you feel is pertinent to your application, such as volunteer work and extracurricular activities. Use additional sheets if necessary.
- Proof of acceptance, or enrollment, as a full-time student at an accredited four-year college or university.
- High school students – submit your official high school transcript and your SAT or ACT scores.
- College students – submit only your official college transcript.

*Your application may be handwritten. Your personal statement **must** be typed or computer printed. Any application containing a handwritten personal statement **will be disqualified**.*

Your application must contain your **official** transcript in order to qualify for review by the CAHP Credit Union Scholarship Committee. Your transcript must be in a sealed envelope bearing the stamp from the institution that the official transcript is enclosed. Official electronic transcripts may be sent to scholarships@cahpcu.org. It is the responsibility of the applicant to ensure that any mailed item contain a postmark.

The Scholarship Committee will meet in July to select the individual winners. Winning applicants will be notified by mail with a letter of confirmation shortly after the Scholarship Committee makes its decisions. The Scholarship funds will be deposited directly to the winners' CAHP Credit Union accounts.

All decisions of the CAHP Credit Union Scholarship Committee are final.

Submit completed applications by **June 29, 2018**. If you are applying by email, you will need to submit all documents together. All transcripts must be emailed by official electronic transcript or mailed to the Sacramento office.

If you are unable to apply electronically, you may mail or deliver your application. Your application must be postmarked or delivered by **June 29, 2018**.
